

# DECLARATION

I, the undersigned .....,  
PIN....., permanently residing .....

Acting in my capacity of parent/guardian of .....  
....., PIN..... - user of the services of Pamporovo AD, provided on  
the land of the ski area of Pamporovo Resort, hereby declare:

1. Of my own will and entirely at my own responsibility and risk, my child/dependent will use the passenger cableways and practice mountain biking on the land of the ski area of Pamporovo Resort.
2. In my own opinion, my child/dependent has the necessary level of skills for practising mountain biking on the land of the ski area of Pamporovo Resort.
3. In my own opinion, the mental and physical condition of my child/dependent at the time of signing this Declaration allows them to undertake at their own risk the use of passenger cableways and mountain biking on the land of the ski area of Pamporovo Resort, and any possible adverse effects on their life and health as a result of my own misjudgement shall be entirely for my own account.
4. I am personally responsible for the condition of my child/dependent's own bike and equipment and I undertake to keep them in good condition while my child/dependent is practising mountain biking on the land of the ski area of Pamporovo Resort.
5. I am aware that mountain biking and descending activities are dangerous and involve a risk of accident, including death, permanent and temporary loss of and/or damage to property, and I expressly assume this risk. I am aware of the risks I take, which may be related to terrain and meteorological conditions, natural disasters, personal physical condition, equipment and facilities, actions and/or inactions of third parties, presence of forest animals, etc.
6. My child/dependent and I are familiar with the routes of the trails suitable for practising mountain biking on the land of the ski area of Pamporovo Resort, as well as with the degree of difficulty of the different trails available.
7. My child/dependent does not suffer from diseases or conditions equivalent to diseases (including addictions of various kinds - alcoholism, drug addiction, etc.), which would endanger the life, health and safety of other cyclists and pedestrians, and that my child/dependent does not need special care or any medical supervision or treatment.
8. I am aware that Pamporovo AD is not responsible, does not pay compensations and benefits of any kind (property and non-property) in case of accident, including death, permanent and temporary disability, medical expenses and costs for repatriation on the land of the ski area of Pamporovo Resort, which result from behaviour of non-compliance with my condition and capabilities, with the specific climatic conditions, with the instructions and restrictions announced publicly by Pamporovo AD on the information boards and on the official website of the company, as well as with the instructions given by the staff servicing the passenger cableways.
9. I am aware that Pamporovo AD is not responsible and has no obligation to conclude for its own account and to present insurance providing compensation in case of accident, including death, permanent and temporary disability, medical expenses and repatriation costs of the tourist, resulting from an accident, and I have been informed that, at my own request and for my own account, I can conclude an individual insurance with an insurer at my discretion for such insurance coverage for my child/dependent.
10. My child/dependent will unconditionally comply with all safety rules, including instructions and orders of the employees of Pamporovo AD responsible for the cableways and facilities.
11. By signing this Declaration, I agree to the collection and use of both my personal data and the personal data of my child/dependent in compliance with the Privacy Policy of Pamporovo AD, published at [www.pamporovo.me](http://www.pamporovo.me).

All described conditions also apply to the use of the ski area of Chepelare (Mechi Chal).
